- Research Festival - Project based poster presentation was conducted to promote research culture among students on 21<sup>st</sup> January 2012.
- Samanvay : Integrated Departmental Festival was conducted by all departments.
- Under Student Exchange under OMG programme i.e. Ontario- Maharashtra- Goa Programme, two students from Queen's University, Canada visited Ruia College to study at the Center for Slum Studies. They also took courses in arts faculty departments. Josephine Haworth-Lee took courses in Departments of Economics and Philosophy for one semester along with Slum studies while Shreya Talwar took courses in Departments of History and Politics for two semesters along with Slum studies. Two students from Ruia College were selected under the same programme- Pooja Bhalerao from TYBSc Life Science at Western Ontario University, Canada (with a scholarship of \$2500) for two semesters and Karishma Prabhu from TYBSc Chemistry at the Broke University, Canada for one semester. One more student, Priya Ramesh of TYBA Economics has been selected by the Western Ontario University, Canada (with a scholarship of \$2500) for two semesters for the academic year 2012-2013. Further, one student from Canada is seeking admission in the Mass Media programme at Ruia College under the same facility.
