I/C Principal, Dr. AnushreeLokur welcomed all the Members to the Third Academic Board Meeting held on 06 July, 2018 at 11:00 am.

The meeting proceeded with Dr. Lokur in the Chair.

Agenda item No.01: To review minutes of last Academic Board Meeting held on 26 March, 2018.

Before confirming the minutes of second meeting, Dr. Lokur briefed the members on changes made in the Board Member Committee. She formally congratulated Dr. SuhasPednekar (in absentee) for his appointment as the Vice Chancellor of the University of Mumbai, leading to her appointment as the I/C Principal of RamnarainRuia Autonomous College.

She also welcomed Mr. Sunil Shankardwar, the newly appointed Exam In-charge who would act as permanent invitee to the Academic Board, as per **Resolution No.: AB/2.8.1** passed in last Academic Board Meeting.

The Minutes of the last meeting, held on 26 March, 2018, were placed before the members and resolutions passed therewith were reiterated.

Dr.Lokur explained that Syllabi for most departments had been passed in the last meeting. Some departments made minor changes, additions and omissions fromtheir syllabi as per suggestions from members given during the last meeting, details of which are given below.

There was extensive discussion and feedback on the Foundation Course paper and its components during the last Academic Board meeting. The Syllabus for the same was modified as per suggestions from the Board.

All members unanimously approved the minutes of the second academic board meeting held on 26 March, 2018.

Dr. AnushreeLokur informed the members that there were minor changes in for of additions and/or omissions of topics asper University requirements and suggestions made by the Academic Board in the last meeting.

Resolution No.: AB/2.3.5:

Shebriefly presented the changes that have made in the syllabus for various **BA programs** (under the Arts faculty for the subjects of Economics, Foundation Course, Marathi, Psychology);

B.Sc. programs(under the Science faculty for the subjects of Biochemistry, Biotechnology (Regular as well as Applied Component), Computer Science, Mathematics, Microbiology,); **Vocational graduate program (B.Voc.)**(in the subject of Tourism and Travel Management); with the requisite credits and corresponding number of lectures. It was noted that the proposed changes in the syllabus has been approved by the respective Subject Boards.

She asked the permission of this body to allow these changes in the syllabus and it was resolved that these changes will be implemented from the academic year 2018-19 with their permission.

Prof. Samant recommended that a Booklet detailing the Syllabi for each department be drafted and presented to the Board in the next meeting. This was affirmed by Dr. Lokur who assured the Board that said Booklet was under preparation and would be ready shortly.
